

# HSBC London Sevens ticket giveaway 2016

## Prize draw Terms and Conditions

1. These Terms and Conditions govern the 'Win tickets to the HSBC London Sevens 2016' prize draw ('Prize Draw') and apply to you as far as the law permits so please read the carefully.

The 'Promoter' of this Prize Draw is HSBC Bank plc (HSBC). HSBC is authorised by the Prudential Regulation Authority and regulated by the Financial Conduct Authority and the Prudential Regulation Authority. It is listed with the registration number 114216. HSBC is a company incorporated under the laws of England and Wales with company registration number 14259, and has its registered office at 8 Canada Square, London E14 5HQ. ### Can I enter the Prize Draw?

3. No purchase or entry fee is necessary to enter this Competition.

4. This Prize Draw is only open to current HSBC Customers aged 18 years and over who are residents of England, Wales or Scotland. Residents of Channel Islands, Isle of Man, Northern Ireland and non-UK addresses may not enter. Entrants who cease to fulfil any of these criteria at any time prior to the award of a prize will be disqualified, even if they met the criteria at the time of entry.

5. The Prize Draw is not open to any HSBC employees or those who have been involved in setting up or running this Prize Draw.

### How do I enter the Prize Draw?

Enter your full name, email address, phone number and post code and click 'Submit' to enter.

8. Each person may enter the prize draw only once and agrees to the Prize Draw terms and conditions when doing so.

### What are the Prizes?

There are six main prizes consisting of a pair of general admission tickets (ie, two tickets) to HSBC London Sevens on Sunday 22 May 2016 at Twickenham Stadium, UK, as well as one twin hotel room on Sunday 22 May 2016. ### How are the winners selected?

13. The Promoter will endeavour to contact all winners by email and phone within two working days of the Prize Draw closing. The email sent to the prize winners will include details of their prize and how to claim it. Prizes which have not been claimed by 5pm on 19 May 2016 will be forfeited. The Promoter reserves the right to determine an alternative winner if any prize is not claimed.

14. There will be no cash, or part cash equivalent: the prize is non-transferable, non-negotiable and non-refundable. If the prize offered is unavailable due to circumstances beyond the control of HSBC/the Promoter, they reserve the right to substitute the prize for one of equal or equivalent value.
